██████████, date of birth 12/2/1975, was interviewed over video conference by AUSA ██████████, AUSA ██████████, Special Agent ██████████ and Detective ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ currently lives in London. She was born in ██████████. She has a bachelor's degree from the University of ██████████. She worked as a secretary at the University. She also worked in fashion and as a model. She worked as a primary school teacher. When she was 27 years old she moved to Brooklyn New York. ██████████ moved in with an old friend from the University. She lived with ██████████. Then after some time she just lived with ██████████.

She attended school in New York, and met a boy at this school. Then she met this boy's sister named ANA. They went to lunch together and hung out. ██████████ asked ██████████ personal questions. A few days later ANA called ██████████ and said that there was a man that needed a massage and he pays good money. She said "you can practice your skills" (when ██████████ was in the university she studied massage for about 6 months). He didn't have an injury; he just wanted a massage.

At this time ██████████ English was not that great. She said that life in Brazil was tough prior to coming to New York. She wanted to do better and help people. ANA told ██████████ to go see him and she agreed. She recalled going to his house and the maids told her to go to the massage room. JEFFREY EPSTEIN came in wearing a towel around his waist. He introduced himself and laid down. ██████████ massaged him for about an hour. Afterwards he asked her questions. ██████████ English was bad. Their conversation was short and he paid her \$200-\$300. He asked her if she wanted to come back and she said yes.

Days later, his assistant called and invited [REDACTED] to come back. She went back and the same thing happened. After the massage EPSTEIN asked her more questions. EPSTEIN asked [REDACTED] to come live near him. He told her she could work more for him and massage him more.

[REDACTED] moved to his apartment and was very happy. She thought he was going to help her with her education. EPSTEIN told [REDACTED] she needed to learn English first.

A few weeks later, EPSTEIN invited [REDACTED] to his Florida house. She went there with three girls on his plane. The only girl of the three that she recalled was SUSANNE HUNTLY. During this plane ride one of the girls may have had sex with EPSTEIN. [REDACTED] kept quiet and thought that maybe the girl who had sex with him was his girlfriend.

Once they get to Florida there are other girls at this house. Once they get to his house they all go to his massage room and EPSTEIN tells them to massage each other. She recalled [REDACTED] being in the room. [REDACTED] massaged [REDACTED] but it was not sexual.

The next day they hung out by the pool. There was a Brazilian girl there named [REDACTED]. They walked on the beach with EPSTEIN. EPSTEIN worked out. They took some pictures by the beach and by the pool. [REDACTED] left the house and they went to the shopping mall. The girls were buying lingerie. They went to the movies then they went back to EPSTEIN's house.

EPSTEIN called [REDACTED] and took her to his room. He started taking her clothes off. He threw her on the bed and touched her everywhere. She recalled that the table next to the bed was slightly open and there was a gun inside of it. EPSTEIN then had sex with [REDACTED]. When he was done he told her she could go back to her room. She went back to her room and fell asleep. She did not leave all night and she was scared he might come in.

The next morning, he came into her room and jumped into bed with her and the same thing happened again. After this, [REDACTED] went downstairs. There was a chiropractor there and he was cracking EPSTEIN's back. EPSTEIN asked who was next and [REDACTED] said that she did not want to do that. EPSTEIN got upset. Another girl told [REDACTED] that "you never say no to EPSTEIN". EPSTEIN wanted [REDACTED] to go to the island but [REDACTED] did not want to go. He then sent her back to New York.

At some point when [REDACTED] was in New York she went back to see EPSTEIN. He told her to give him a back massage. During this massage, EPSTEIN talked down to [REDACTED] about the whole Florida situation. He said that because of that he was going to punish her. He proceeded to throw [REDACTED] around and ripped her clothes off. EPSTEIN forced anal sex on [REDACTED]. When he finished he told her to take a shower. He paid her and told her to go to her apartment.

[REDACTED] cried and was alone and confused and upset. [REDACTED] lived in this 2-bedroom apartment alone.

[REDACTED] described EPSTEIN's house in New York to be the townhouse on 71st street. She would have to wait in the library for the maid to take her in the elevator and up to the massage room. [REDACTED] and [REDACTED] were EPSTEIN's assistants in New York who would call [REDACTED]. [REDACTED] was another New York assistant.

At some point, [REDACTED] was invited to come back to EPSTEIN's. She went back and the same thing happened to her. Another time, she's invited back and again the same thing happened.

[REDACTED] eventually moved into the other room of the apartment. They went to EPSTEIN's house and sometimes no sex would happen. [REDACTED] visited EPSTEIN's office on Madison Avenue. She met [REDACTED], [REDACTED] and LESLEY.

While living at the apartment on 66<sup>th</sup> street she was in either 8M or 8D. This was in 2003 up until November. Then she moved back to Brazil until about January of 2004. When she returned, EPSTEIN put her in a different apartment in the same building, possibly on the 4<sup>th</sup> floor. She was there until March of 2004 and then she went back to Brazil. She recalled coming back to New York on April 5, 2004. EPSTEIN paid for her trips back and forth. EPSTEIN said that he did not have an apartment for her. She was placed with [REDACTED] and a girl from Sweden. The girl from Sweden, whose name [REDACTED] could not recall, was about 16-17 years old and was a nanny for EPSTEIN's ex-girlfriend. Apparently, she was reporting back to EPSTEIN about what [REDACTED] and [REDACTED] did. One day, the Swedish girl's parents came with her brother to the apartment to pick her up to take her to travel.

One day, EPSTEIN told [REDACTED] that she was going to go on a vacation.

[REDACTED] English was still bad so she did what he told her to do. He booked a

trip to Los Angeles and told her it was for her and the girls. He said she was going to meet people there.

[REDACTED] arrived in Los Angeles and went to the Beverly Hills Hotel. A woman who worked at the hotel took her to a presidential suite. She met a man named GEORGE MITCHELL inside of this room. She did not know who he was but just knew he was a friend of EPSTEIN's. As she met him in the room he was on the phone with EPSTEIN. He introduced himself and he was doing some work. He told [REDACTED] that she would be staying with him in this room. They then went for a walk and went shopping. They returned to the hotel and had dinner. MITCHELL asked for a massage. He then asked for a blow job and sex so she complied. [REDACTED] did what she was told.

The next day, MITCHELL told [REDACTED] to stay in the hotel. [REDACTED] stayed by the pool and went back to the room. Later, MITCHELL wanted to have sex again so they did. Then they went shopping for suits. There was another man there when they were shopping for suits. Afterwards, they went back to the room. MITCHELL wanted to have sex two more times.

[REDACTED] then went back to New York. EPSTEIN said that she was doing very well and MITCHELL was a good friend of his. [REDACTED] eventually went back to Brazil.

Before going back to Brazil, [REDACTED] saw EPSTEIN a lot. It was not always sexual. LESLEY set [REDACTED] up one day with a train trip to Washington DC. [REDACTED] took the train from PENN station. She went and ended up meeting MITCHELL again. On the trip down to DC, EPSTEIN called [REDACTED] to check up on her. [REDACTED] arrived in DC and went to the 4 Seasons Hotel. She went to the front desk to check in and was told that they do not have a reservation for her. [REDACTED] waited in the lobby and observed MITCHELL walk in. He walked up to [REDACTED] and the reception and told her to come with him. They went to his room and he said that she was going to stay with him. MITCHELL wanted [REDACTED] to shower with him. He wanted a blow job and sex. MITCHELL talked about EPSTEIN.

The next day MITCHELL has sex with [REDACTED] again then went to work. [REDACTED] walked around and hung out in the hotel. She then wrote MITCHELL a note stating that she was leaving and wanted to go back to school. [REDACTED] went home and did not want to go to the police. She did not report because she

was scared. EPSTEIN called her the next day yelling at her, being very loud, angry and mean.

There were no gifts or money exchanged while in DC. There was not much conversation as her English was bad. [REDACTED] described MITCHELL as being slim and very old. He was tall but not too tall. He had soft skin and was white. He was very nice, happy and he smiled. He had gray hair but not much hair. He told [REDACTED] that he worked in politics. [REDACTED] thought that MITCHELL knew that she took a train to DC. While she was in Los Angeles MITCHELL and [REDACTED] did not talk about her travel.

[REDACTED] discussed a girl named [REDACTED] [REDACTED] who once shared an apartment with her in New York. She was about 16 years old. EPSTEIN was giving a present to another girl in this apartment at that time. She was from the Karin Model Agency. [REDACTED] would go to Paris with JEAN-LUC and EPSTEIN.

[REDACTED] recently contacted [REDACTED] and she had said that nothing happened to her.

[REDACTED] was asked if she talked to anyone else about her trips to see MITCHELL to which she said no.

[REDACTED] was in a car one time with [REDACTED] and [REDACTED]. [REDACTED] did not contact [REDACTED] after she arrived. [REDACTED] was in [REDACTED] apartment and [REDACTED] had to live with [REDACTED]. All of [REDACTED] stuff was gone when she returned.

[REDACTED] wanted to go to Kaplan school and EPSTEIN paid for her to go for 6 months in 2004.

Then she would only see EPSTEIN at his office. EPSTEIN wanted [REDACTED] to meet his friend. EPSTEIN said he was well known. [REDACTED] went to meet LEON BLACK at a big house. They met in a big conference room and he took her number. They talked about life.

That same week, BLACK's secretary called [REDACTED] and stated that BLACK wanted to meet her. [REDACTED] went to his house and he showed her around. He took her to a room. BLACK wanted to have sex with [REDACTED]. He said he would organize something for her. Afterwards, she left.

[REDACTED] saw BLACK four times all in New York all in 2004. She recalled that he would take a long time to finish and that he would sweat a lot during

sex. He told [REDACTED] that he had a nose operation and that's why he would also breathe very heavy during sex with [REDACTED]. She described him as being tall, heavy with a large stomach. He had gray hair, a big nose and a mole on his face. BLACK's assistant would contact [REDACTED] to go see BLACK. She would say that BLACK wanted a massage. The last time that [REDACTED] saw BLACK was around June of 2004

[Agent note: There was a short break and Detective [REDACTED] left the interview.]

[REDACTED] stated that after leaving Los Angeles she and MITCHELL took the same car to the airport. [REDACTED] traveled back to New York but was not sure where MITCHELL went.

In June or July [REDACTED] went to Montreal where she met her husband. When she came back she received calls from EPSTEIN's secretary but didn't pick up. [REDACTED] did not want to continue doing that. [REDACTED] moved out of the 66th Street building in March. She moved to a small apartment and traveled with her boyfriend of the time. They went to Italy, Los Angeles, Brazil and then they moved to England after she finished school.

In approximately 2008/2009, [REDACTED] emailed EPSTEIN. [REDACTED] went to a wedding and met [REDACTED] there. EPSTEIN was in prison or had just gotten out. EPSTEIN emailed [REDACTED] back, telling her he wanted photos of her. [REDACTED] told him he could see photos of her on Instagram or Facebook.

[REDACTED] went to New York with her husband. [REDACTED] met [REDACTED] and said she would like to see EPSTEIN; [REDACTED] wanted EPSTEIN to see that she was happy. [REDACTED] went to EPSTEIN's home in New York and he took her to the kitchen. PRINCE ANDREW was in the kitchen with another girl. [REDACTED] recognized PRINCE ANDREW and was quite shocked to see him. [REDACTED] described the girl as being approximately 20 something and able to speak good English but not an American. EPSTEIN told his PRINCE ANDREW that [REDACTED] was good at massages. EPSTEIN asked [REDACTED] to massage PRINCE ANDREW's shoulders and back. [REDACTED] started massaging PRINCE ANDREW's back. EPSTEIN left the room and came back to the room with a camera. PRINCE ANDREW then told [REDACTED] it was her turn to be massaged. PRINCE ANDREW massaged [REDACTED] back, shoulders, waist, and hands. Everyone had clothes on during these massages. [REDACTED] just wanted to leave. EPSTEIN then told [REDACTED] to come with him and he took her to a

different room from the room where PRINCE ANDREW and the girl was in; EPSTEIN then pushed her against the wall trying to take her top off. EPSTEIN told [REDACTED] he wanted to take a picture of her. [REDACTED] told him he could take a picture but she would not let him take her top off. EPSTEIN asked [REDACTED] about her marriage and told her she could do well in London. EPSTEIN told her that marriage could be boring and they could do things together.

In or around 2003/2004, it was always just EPSTEIN and [REDACTED] in the room when sexual incidents would happen.

[REDACTED] and LESLEY would call [REDACTED] to come over to EPSTEIN's home, more so LESLEY would call. When [REDACTED] would go to EPSTEIN's home, she would see a bunch of girls and there would be a different group of girls at different times. [REDACTED] recalled seeing [REDACTED], [REDACTED], and meeting [REDACTED] once. [REDACTED] recalled she and [REDACTED] being in a car together and going shopping together.

[REDACTED] was asked if she recalled the name GHISLAINE MAXWELL. [REDACTED] remembered something on a voice machine that related to MAXWELL. [REDACTED] thought it was something in relation to a drop off or pick up. [REDACTED] wrote MAXWELL's name in her diary; [REDACTED] had written down MAXWELL's phone number. [REDACTED] recalled seeing letters via mail that arrived at the apartment addressed to MAXWELL. [REDACTED] never met MAXWELL.

[REDACTED] recalled walking into the room in Los Angeles to meet MITCHELL and MITCHELL being on the phone with EPSTEIN. MITCHELL said into the phone, "She's here".

[REDACTED] recalled when she went to DC, MITCHELL told her EPSTEIN told him that she would be staying with him. MITCHELL told her EPSTEIN sent her there. [REDACTED] had asked the receptionist if she had a reservation, but there was nothing in her name. [REDACTED] was there because EPSTEIN sent her to DC. [REDACTED] was in the room with MITCHELL and felt that she had no where to go. [REDACTED] recalled seeing a gun in EPSTEIN's home in Palm Beach and that is what she had in her mind during this time. [REDACTED] was scared. [REDACTED] also had it in her mind recalling when a girl told her she could not say no to EPSTEIN.

[REDACTED] was asked if she recalled the last names of [REDACTED], [REDACTED], [REDACTED], and [REDACTED]. [REDACTED] did not recognize [REDACTED] last name at the time but had

since looked it up. [REDACTED is known to law enforcement as [REDACTED] [REDACTED].] [REDACTED] had looked up LESLEY's name, but did not recall it. [LESLEY is known to law enforcement as LESLEY GROFF.] [REDACTED] recalled [REDACTED] last name began with a "M" and described her as tall and blonde. [REDACTED is known to law enforcement as [REDACTED] [REDACTED] aka [REDACTED] [REDACTED].] [REDACTED] did not know [REDACTED] last name but came to learn that it was [REDACTED] [REDACTED] and recognized a photo of her she had seen. [REDACTED] [REDACTED] is also known to law enforcement as [REDACTED] [REDACTED] aka [REDACTED] [REDACTED].]

Sometimes EPSTEIN gave [REDACTED] money. EPSTEIN paid for trips for [REDACTED] and paid for [REDACTED] schooling. EPSTEIN gave [REDACTED] a place to live and [REDACTED] did not have to pay rent when she lived in the apartment. When [REDACTED] met her husband, EPSTEIN helped support her. [REDACTED] came back from Brazil and she was designing swimwear and jewelry and EPSTEIN bought items from her. [REDACTED] recalled EPSTEIN buying a lot of swimwear.

When [REDACTED] was asked if she told MITCHELL anything about herself, she responded that she did not tell him anything and he never asked. MITCHELL had told [REDACTED] to go to a museum and she was too embarrassed to tell him that she did not have any money so she just walked around the block before going back to the room. [REDACTED] did not refuse anything that MITCHELL did; she just did what she was told to do.

[REDACTED] never had MITCHELL's phone number. [REDACTED] did have BLACK's phone number.

[REDACTED] was the one who introduced [REDACTED] to EPSTEIN.

[REDACTED] currently is a swimwear designer and online retailer. [REDACTED] is married with two children.
