██████████, date of birth ██████████ was interviewed over the phone by AUSA ██████████, AUSA ██████████, Detective ██████████ and Special Agent ██████████. Also on this call was ██████████ attorney AITAN GOELMANA. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ went to high school in Rhode Island and attended college in Ohio. She graduated college in 1986 and moved on to study at the New Center School for health and massage therapy. ██████████ graduated in 1990.

In the late 1980's she worked various jobs in television as a production assistant. She also does some jobs in modelling and acting.

Currently, ██████████ is a health coach and does body work with clients based in California.

When ██████████ was 29 years old (approximately 1993) she was working with a client who referred her to GHISLAINE MAXWELL. This was around winter time and ██████████ massaged MAXWELL twice. ██████████ was living in New York City at the time and massaged MAXWELL in her small upper east side apartment. MAXWELL then referred ██████████ to JEFFREY EPSTEIN telling her that he needed his feet worked on.

██████████ goes to EPSTEIN's upper east side townhouse around 76 street. It was not his mansion. ██████████ worked on his feet. EPSTEIN asked if she could massage him more on a regular basis to which she says yes. About one week later ██████████ started seeing EPSTEIN on a regular basis. She would see him about everyday if not every other day. She would see him around 9am. She did this for about two years but not when he traveled.

EPSTEIN had a gym room for palates and ballet which had a massage table

in it. [REDACTED] worked on him in both New York and Palm Beach. When she went to Palm Beach he would fly her on his private jet. In the beginning she was going there about every other weekend. This went on until approximately May. [REDACTED] would stay in a guest room at his residence.

When she would travel to Palm Beach, MAXWELL would sometimes travel with her. A woman named FRANCES LNU, who [REDACTED] referred to as EPSTEIN's girlfriend, would also sometimes travel.

It seemed like to [REDACTED] that MAXWELL and EPSTEIN were dating at first but later thought that they were just friends. MAXWELL behaved as if they were dating. MAXWELL would kiss him and put her arms around him.

[REDACTED] traveled with EPSTEIN for a total of six years, but the last four years of her time with him she traveled much less often than every other weekend. Other homes of EPSTEIN's that [REDACTED] traveled to was Paris, Little Saint James, Ohio and Chicago. During this six year period [REDACTED] was paid about \$100 for each massage she gave and was not paid a salary. She did not have any other job responsibilities. She did on occasion massage other people. She would massage whoever EPSTEIN's girlfriend was at the time, MAXWELL (perhaps only two times), FRANCES, [REDACTED], PRINCE ANDREW (most recently at the New York house) and DONALD TRUMP (massaged his feet on the plane from Palm Beach to New York). [REDACTED] massaged two male friends of EPSTEIN's but does not recall their names.

[REDACTED] never showed someone how to massage. [REDACTED] knew of a woman named [REDACTED] who was a Florida based massage therapist who used to work on EPSTEIN.

After this six years [REDACTED] stopped working for EPSTEIN because she got a divorce from her husband and moved to California. EPSTEIN would call to check in with [REDACTED] on occasion after this but [REDACTED] did not work for him. EPSTEIN asked [REDACTED] to work on a man who came to California on one occasion but she does not remember his name.

[REDACTED] does not recall anything weird or odd with her relationship with EPSTEIN.

[REDACTED] recalled a cook named JOHN and his wife would work in Palm Beach. She recalled a man named JOJO and his wife LYNN who worked for EPSTEIN in

New York. She recalled a husband and wife couple that worked for EPSTEIN at Little Saint James but does not recall their names. [REDACTED] does not recall any other frequent travelers with EPSTEIN.

[REDACTED] does not recall minor females being around EPSTEIN's homes. She recalls women in their early 20's, specifically FRANCES and [REDACTED].

[REDACTED] was asked about flight records. [REDACTED] recalls in 1994 being on a plane with FRANCES, EPSTEIN's girlfriend. Flight records show they flew to Michigan but [REDACTED] and FRANCES do not appear on the return flight. [REDACTED] does not recall that flight going to Michigan but references a similar flight that was to Chicago. She states that it has happened that they would fly to a particular location on his jet, and return home separately on a commercial flight. She is not sure why this would happen. [REDACTED] also recalls flying with DAWN DEVITO in 1994. DEVITO was a yoga instructor. [REDACTED] (possibly EPSTEIN's god daughter) also flew with [REDACTED]. In 1995 [REDACTED] may have flown with [REDACTED] but not sure.

[REDACTED] recalls EVA being the mother of [REDACTED] who was friends with EPSTEIN and lives in New York. [REDACTED] does not recall someone named [REDACTED].

The last time [REDACTED] speaks with EPSTEIN was around March of 2019. Prior to that EPSTEIN would contact [REDACTED] every few months to check in.

EPSTEIN called [REDACTED] the first time he was arrested to tell her that he was going to prison. He let her know that he was going to jail for a year and a half and did not tell her why. [REDACTED] doesn't specifically recall what he said about why he was going to jail but thinks maybe it was discussed.

About 20 years ago was the last time [REDACTED] spoke with MAXWELL.

[REDACTED] recalls a trip to Aspen with FRANCES.
